# B. Scope of Work

#### 1. Project Overview:

- 1.1. The purpose of this tender is to invite bids from Microsoft Authorized Licensing Solution Providers (LSP) or Large Account Resellers (LAR) for the implementation of Microsoft products under an Enterprise Agreement for a period of 3 years from the date of signing the agreement. This will encompass the following areas:
- 1.2. Provision, activation, and configuration of Microsoft product licenses as detailed in the Bill of Quantity (BOQ).
- 1.3. Migration of NHAI's email systems, including subsidiaries, from the current On-premises MS Exchange 2013 to Microsoft Office 365-based email systems.
- 1.4. Upgrade of the current On-premises Active Directory solution based on Windows Server 2012 to Windows Server 2022, aligned with NHAI's requirements.
- 1.5. Configuration and integration of Active Directory Connect (AD Connect) with the On-premises Active Directory solution to enable authentication for all Office 365 services.
- 1.6. Provision of administrative and user training on all Office 365 modules by Microsoft Certified Professionals (in relevant technologies). Training for administrators will be conducted on-site, while user training will be provided online.
- 1.7. The bidder will be responsible for coordinating and facilitating the necessary arrangements with Microsoft to finalize the Enterprise Agreement with NHAI.

### 2. Deployment of Microsoft Office 365 Services - Infrastructure:

The scope of work includes the procurement, activation, and deployment of the necessary licenses specified in the BOQ. It also covers one-time implementation, training, and support services over a period of 3 years. The tasks are categorized as follows:

### 2.1. Supply of Licenses as per BOQ:

- 2.1.1. Provision, activation, and configuration of Microsoft product licenses as outlined in the Bill of Quantity.
- 2.2. Installation and Configuration of Email Services for Licensed Users.
- 2.2.1. Set up an Office 365 tenant, create users, and assign licenses. Configure the domains of NHAI and its subsidiaries in the Office 365 tenant.
- 2.2.2. Provision users in Office 365 using the Azure AD Connect tool (hardware for AD Connect will be provided by NHAI).
- 2.2.3. Configure Autodiscover, SPF Records, and other required settings in the Public DNS.
- 2.2.4. Migrate mailboxes from On-premises Exchange 2013 to Office 365 email. Any configurations needed on NHAI's servers will be handled by the bidder.
- 2.2.5. Set up email forwarders for each user to redirect emails from the existing Exchange 2013 to the new Office 365 tenant.
- 2.2.6. Migrate archived emails stored on users' local machines using an appropriate technology or methodology.
- 2.2.7. Configure transport rules and litigation hold rules for eligible accounts.
- 2.2.8. Recreate and configure existing static and dynamic distribution lists from Exchange in the Office 365 environment.
- 2.2.9. Ensure the solution supports industry-standard protocols such as SMTP and ActiveSync.
- 2.2.10. Implement centralized e-discovery for Office 365 E3 and enable Global Address List (GAL) search capabilities to locate relevant information across organizational mailboxes.

### Note:-

- 1. The OEM Manufacturer Authorization Form (MAF) is required for above Microsoft products. The client will verify the MAF from OEM.
- 2. The warranty for three (03) years will start from the date of installation and installation certificate along with specification must be submitted before release of payment.
- 3. The responsibility of maintaining the serviceability of the Microsoft products and associated support from the OEM for the entire duration of the warranty of the items will be of the successful bidder. The supplied products must be compatible with existing products.
- 4. Installation and implementation by successful bidder as follows.
  - Presently, Email services to employees in NHAI is provided through on-premises Microsoft Exchange 2013 (2000 accounts).
  - Microsoft Active Directory Service based on Windows Server 2012 is deployed to centrally manage user authentication.
  - Supply, activation, configuration of Microsoft product licenses as per Bill of Quantity.
  - Migration of NHAI email systems from existing On-premises MS Exchange 2013 infrastructure to Microsoft online Exchange based email system (domain: nhai.org).
  - Up-gradation of existing on-premises Active Directory solution based on Windows Server 2012 to on-premises latest Windows Server as per NHAI requirements.
  - Microsoft System center configuration manager installation and configuration.
  - Imparting administration and usage trainings on all Office 365 modules, online exchange, active directory through the Microsoft's Certified (relevant technologies) professional for the various components of the proposed solution. The mode of training shall be on-site for administrators & online for users.

- 5. The successful bidder will provide the following: -
