4. The RFP consists of five parts consisting of **33 Pages** as indicated below:-

Part I - Contains General Information and Instruction for the Bidders about the RFP such as the time, place of submission and opening of tenders, Validity period of tenders, etc.

Part- II - Contains essential detail of the items/Services required, such as the schedule of requirements (SOR) Technical Specification, Delivery Period, Mode of Delivery and Consignee detail.

Part – III.Contains Standard Condition of RFP, which will form part of the Contract with the successful Bidder.

Part – IV - Contains Special Conditions applicable to this RFP and which will also form part of the contract with the successful Bidder.

Part - V Contains Evaluation Criteria and format for Price Bids.

5. This RFP is being issued with no financial commitment and the Buyer reserves the right to change or vary any part thereof at any stage. Buyer also reserves the right to withdraw the RFP, should it became necessary at any stage

Section-II

Part I-General Information

1. **Last Date And Time For Quoting The Bids.** The bids should be quoted (filled in BOQ) by the due date and time. The responsibility to ensure this lies with the Bidder.

(BIDS TO BE QUOTED LATEST BY AS MENTIONED IN PORTAL)

2. Manner of Depositing the Bids: **(GeM Portal Enquiry** (Bids to be filled in BOQ).

3. Place for opening of the Bids: E-Bids will be opened in OIC E3 (Prov) ESD kankinara-743124 the Bid opener.

4. ~~**Single Bid System:** The bids are invited on single bid two stage systems. The Bids would be opened on the time and date mentioned in the Portal.~~

5 **Modification and Withdrawal of Bids.**

(a) The Bidder may modify (resubmit) his bid after submission, as per the provisions available on the portal. No bid shall be modified after the deadline for submission of bids.

(b) No bid may be withdrawn in the interval between the deadline for submission of bids and expiry of the period of the specified bid validity.

6. **Clarification Regarding Contents of the RFP:** A prospective bidder who requires the clarification regarding the contents of the bidding documents shall contact the Buyer over the phone No given at Ser No 2 above, prior to the date of opening of the Bids.

7. **Clarification Regarding Contents of the Bids.** During evaluation and comparison of bids, the Buyer may, at its discretion, ask the bidder for clarification of his bid. The request for clarification will be given in writing and no change in prices or substance of the bid will be sought, offered or permitted. No post-bid clarification on the initiative of the bidder will be entertained.

8. **Unwillingness to Quote** : Bidders unwilling to quote should ensure that intimation to this effect reaches before the due date and time of opening of the Bid, failing which the defaulting Bidder may be delisted for the given range of items as mentioned in this RFP.

9. **Validity of Bids:** The Bids should remain valid till **180 days** from the last date of submission of the Bid.

10. **Agents of Supplier:** One agent cannot represent two supplies or quote on their behalf in a particular tender and different agent should use different computer system.

11. **Tender Fee:-** Not applicable as GFR 2017.

12. **Earnest Money Deposit:** Bidders are required to submit Earnest Money Deposited (EMD) for amount of **Rs 3,24,290.00/- (Rupees Three Lakh Twenty Four Thousand Two Hundred Ninety Only)** along with their bids. The EMD may be submitted in the form of an Account Payee Demand Draft, Fixed Deposit Receipts, Bankers Cheque or Bank Guarantee from any of the public sector banks or a private sector bank authorized to conduct government business as per Form DPM-13 (Available in MoD website and can be provided on request). EMD is to remain valid for a period of **60 Days** beyond the final date of submission of bid. EMD of the unsuccessful bidders will be returned to them at the earliest after expiry of the final bid validity and latest on or before the 30th day after the award contract. The Bid security of the successful bidder would be returned, without any interest what so ever, after the receipt of Performance Security from them as called for in the contract. **EMD is not required to be submitted by those Bidders who are registered with the Central Purchase Organization (e,g DGS&D), National Small Industries Corporation (NSIC) or any Department of MoD itself.** The EMD will be forfeited if the bidder withdraws or amends impairs or derogated for the tender in any respect within the validity period of their tender.

Note :(a) The firms seeking exemption from payment of EMD must submit duly attested copy of registration certificate for the item. The registration should be valid on the date of opening of tenders.

(b) All the self attested documents to be submitted before the date of opening bids.

13. **Forfeiture of the Bid Security.** The bid security/earnest money will be liable to be forfeiture if the bidder withdraws or amends, impairs or derogates from the tender in any respect within the validity period of his tender. No separate order is required for forfeiture of Bid security which follows on default and should be credited at once to the Government Account.

PART II – Essential Details of Items/Services Required

1. **Schedule of Requirement** - As per Appx 'B' attached.
2. **Technical Details** :- All items/materials should be as per relevant IS specification. The CAT part no and specification mentioned in NIT/RFP are for reference purpose only.
3. ~~**Single – Bid System**:- The bids are invited on single bid two stage system. The Bids would be opened on the time and date mentioned in the Portal.~~
4. **Delivery Period** Delivery period for supply of items would be **365 Days** from the effective date of placing supply order by competent authority i.e Commandant ESD Kankinara. Please note that Contract can be cancelled unilaterally by the Buyer in case items are not received within the contracted delivery period. Also the delivery pd of **365 Days** includes the replacement of items being rejected during the inspection. Extension of contracted delivery period will be at the sole discretion of the Buyer, with/without applicability of LD clause.

Note :-

- (a) The successful bidders are requested to submit the **Catalog** mentioning **Cat Part No, Drawing, Specification No** and **Description of items** to the Buyer before the delivery stores.
5. **Terms for Delivery and Transportation - Local Delivery at site**. The purchaser will not pay separately for transit insurance to the supplier. The supplier will be responsible till the entire stores contracted for are received in good condition at consignee destination. The stores will be despatched to the consignee by road or by any other means under arrangement of seller.
6. **Consignee details**. The store will be despatched to the under mentioned consignee as per the supply order.

7. **Piecemeal Supply**: Piecemeal supply of items is acceptable. However the payment will be made according to clause at Part IV Para 5(b&c) of this RFP.

PART III – STANDARD CONDITIONS OF SUPPLY ORDER

The submission of BOQ by the bidder will be assumed as a confirmation of their acceptance of the Standard Conditions of the Request for Proposal mentioned below which will automatically be considered as part of the Contract concluded with the successful Bidder (i.e. seller in the Contract) as selected by the Buyer.

1. **Law.** The Contract shall be considered and made in accordance with the laws of the Republic of India. The contract shall be governed by and interpreted in accordance with the laws of the Republic of India.
2. **Effective Date of the Contract.** The contract shall come into effect on the date of signatures of both the parties on the contract except when some other effective date is mutually agreed to and specifically indicated/provided in the contract and shall remain valid until the completion of the obligations of the parties under the contract. The deliveries and supplies and performance of the services shall commence from the effective date of the contract.
3. **Arbitration.** All disputes or differences arising out of or in connection with the Contract shall be settled by bilateral discussions. Any dispute, disagreement or question arising out of or relating to the Contract or relating to construction or performance, which cannot be settled amicably, may be resolved through arbitration. The standard clause of arbitration is as per Forms DPM-7, DPM-8 and DPM-9 (Available in MoD website and can be provided on request).
4. **Penalty for use of Undue influence.** The Seller undertakes that he has not given, offered or promised to give, directly or indirectly, any gift, consideration, reward, commission, fees, brokerage or inducement to any person in service of the Buyer or otherwise in procuring the Contracts or forbearing to do or for having done or forborne to do any act in relation to the obtaining or execution of the present Contract or any other Contract with the Government of India for showing or forbearing to show favour or disfavour to any person in relation to the present Contract or any other Contract with the Government of India. Any breach of the aforesaid undertaking by the Seller or any one employed by him or acting on his behalf (whether with or without the knowledge of the Seller) or the commission of any offers by the Seller or anyone employed by him or acting on his behalf, as defined in Chapter IX of the Indian Penal Code, 1860 or the Prevention of Corruption Act, 1986 or any other Act enacted for the prevention of corruption shall entitle the Buyer to cancel the contract and all or any other contracts with the Seller and recover from the Seller the amount of any loss arising from such cancellation. A decision of the Buyer or his nominee to the effect that a breach of the undertaking had been committed shall be final and binding on the Seller. Giving or offering of any gift, bribe or inducement or any attempt at any such act on behalf of the Seller towards any officer/employee of the Buyer or to any other person in a position to influence any officer/employee of the Buyer for showing any favour in relation to this or any other contract, shall render the Seller to such liability/ penalty as the Buyer may deem proper, including but not limited to termination of the contract, imposition of penal damages, forfeiture of the Bank Guarantee and refund of the amounts paid by the Buyer.
5. **Agents/Agency Commission.** The Seller confirms and declares to the Buyer that the Seller is the original manufacturer of the stores/provider of the services referred to in this Contract and has not engaged any individual or firm, whether Indian or foreign whatsoever, to intercede, facilitate or in any way to recommend to the Government of India or any of its functionaries, whether officially or unofficially, to the award of the contract to the Seller; nor has any amount been paid, promised or intended to be paid to any such individual or firm in respect of any such intercession, facilitation or recommendation. The Seller agrees that if it is established at any time to the satisfaction of the Buyer that the present declaration is in any way incorrect or if at a later stage it is discovered by the Buyer that the Seller has

engaged any such individual/firm, and paid or intended to pay any amount, gift, reward, fees, commission or consideration to such person, party, firm or institution, whether before or after the signing of this contract, the Seller will be liable to refund that amount to the Buyer. The Seller will also be debarred from entering into any supply Contract with the Government of India for a minimum period of five years. The Buyer will also have a right to consider cancellation of the Contract either wholly or in part, without any entitlement or compensation to the Seller who shall in such an event be liable to refund all payments made by the Buyer in terms of the Contract along with interest at the rate of 2% per annum above LIBOR rate. The Buyer will also have the right to recover any such amount from any contracts concluded earlier with the Government of India

6. **Access to Book Accounts.** In case it is found to the satisfaction of the Buyer that the Seller has engaged an Agent or paid commission or influenced any person to obtain the contract as described in clauses relating to Agents/Agency Commission and penalty for use of undue influence, the Seller, on a specific request of the Buyer, shall provide necessary information/ inspection of the relevant financial documents/ information.

7. **Non-disclosure of Contract documents.** Except with the written consent of the Buyer/Seller, other party shall not disclose the contract or any provision, specification, plan, design, pattern, sample or information thereof to any third party.

8. **Liquidated Damages.** In the event of the Seller's failure to submit the Bonds, Guarantees and Documents, supply the stores/goods and conduct trials, installation of equipment, training, etc as specified in this contract, the Buyer may, at his discretion, withhold any payment until the completion of the contract. The BUYER may also deduct from the SELLER as agreed, liquidated damages to the sum of **0.5%** of the contract price of the delayed/undelivered stores/services mentioned above for every week of delay or part of a week, subject to the maximum value of the Liquidated Damages being not higher than **10%** of the value of delayed stores.

9. **Termination of Contract.** The Buyer shall have the right to terminate this Contract in part or in full in any of the following cases :-

- (a) The delivery of the material is delayed for causes not attributable to Force Majeure for more than **30 Days** after the scheduled date of delivery.
- (b) The Seller is declared bankrupt or becomes insolvent.
- (c) The delivery of material is delayed due to causes for Force Majeure by more than **30 Days** provided Force Majeure clause is included in the contract.
- (d) The Buyer has noticed that the Seller has utilised the services of any Indian/Foreign agent in getting this contract and paid any commission to such individual/company etc.
- (e) As per decision of the Arbitration Tribunal.

10. **Notices.** Any notice required or permitted by the contract shall be written in the English language and may be delivered personally or may be sent by FAX or registered pre-paid mail/airmail, addressed the last known address of the party to whom it is sent.

11. **Transfer and Sub-letting.** The Seller has not right to give, bargain, sell, assign or sublet or otherwise dispose of the Contract or any part thereof, as well as to give or to let a third party take benefit or advantage of the present Contract or any part thereof.

12. **Patents and other Industrial Property Rights.** The prices stated in the present Contract shall be deemed to include all amounts payable for the use of patents, copyrights, registered charges, trademarks and payments for any other industrial property rights. The Seller shall indemnify the Buyer against all claims from a third party at any time on account of the infringement of any or all the rights mentioned in the previous paragraphs, whether such claims arise in respect of manufacture or use. The Seller shall be responsible for the completion of the supplies including spares, tools, technical literature and training aggregates irrespective of the fact of infringement of the supplies, irrespective of the fact of infringement of any or all the rights mentioned above.

13. **Amendments.** No provision of present Contract shall be changed or modified in any way (including this provision) either in whole or in part except by an instrument in writing made after the date of this Contract and signed on behalf of both the parties and which expressly states to amend the present Contract.

14. **Taxes and Duties**

(a) **General.**

(i) Bidder must indicate separately the relevant Taxes/ duties to be paid in connection with delivery of completed goods specified in RFP. In absence of this, the total cost quoted by them in their bids will be taken into account in the ranking of bids.

(ii) If a Bidder is exempted from payment of any duty/ tax upto any value of supplies from them, he should clearly state that no such duty/tax will be charged by them up to the limit of exemption which they may have. If any concession is available in regard to rate/ quantum of any duty/ tax, it should be brought out clearly. In such cases, relevant certificate will be issued by the buyer later to enable the seller to obtain exemptions from taxation authorities.

(iii) Any charges in levies, taxes and duties levied by Central/State/Local government such as excise duty VAT service tax, Octroi/ entry tax etc on final product of upward as a result of any statutory variation taking place within contract period shall be allowed reimbursement by the buyer, to the extent of actual quantum of such duty/ Tax period by the seller. Similarly, in case of downward revision in any such duty/tax, in actual quantum of reduction of such duty/ tax shall be reimbursed to the buyer by the seller. All such adjustment shall include all reliefs, exemption, rebates concession etc, if any obtained by the seller, Section 64-A of sales Goods act will be relevant in this situation.

(iv) Levies taxes and duties levied by Central/State/Local Govt such as excise duty, VAT, service tax, Octroi/ entry tax, etc on final product will be paid by the buyer on actual, based on relevant documentary evidence. Taxes and duty on input items will not be paid by the buyer and they may not be indicated separately in the bid. Bidders are required to include the same in the pricing of their product.

(b) **Customs Duty.**

(i) For imported stores offered against forward delivery, the Bidders shall quote Prices thereof exclusive of customs duty. The Bidder shall specify separately the C.I.F. prices and total amount of customs duty payable. They will also indicate correctly the rate of customs duty applicable along with Indian

Customs Tariff Number. Customs duty as actually paid will be reimbursed on production of necessary documents i.e.

- (aa) Triplicate copy of the bill of entry,
 - (ab) Copy of bill of lading
 - (ac) A copy of foreign principal's invoice. However, if the Seller imports the stores in question against his own commercial quota Import Licenses, he will also be required to submit in addition the triplicate copy of bills of entry etc, a certificate from his internal Auditor on the bill itself, to the effect that the following items/quantity in the bill of entry related to the stores imported against Defence Buyer contract No _____ dated _____.
- (i) Subsequent to the reimbursement of customs duty, the Seller will submit to the concerned payment Authority a certificate to the effect that he has not obtained any refund of customs duty subsequent to the payment of duty to the Customs authority by him. In addition, he shall also submit to the pay Authority concerned a certificate immediately after a period of three months from the date of payment of the duty to customs authorities to the effect that he has not applied for refund for the customs duty subsequent to the payment of duty to the customs authorities by him.
- (iii) In case the Seller obtains any refund of customs duty, subsequently to payment of the same by him to the customs authorities and reimbursement of the customs duty to him by the payment authority, he should forthwith furnish the details of the refund obtained and afford full credit of the same to the Buyer.
- (c) **GST** :-Applicable as per HSN Code.

15. **Pre-Integrity Pact Clause**: Not applicable, as the tender value is less than 100 crores.

PART IV-SPECIAL CONDITIONS OF SUPPLY ORDER

1. **Performance Guarantee.** The successful bidder (Seller) will be required to furnish a Performance Guarantee by way of Bank Guarantee through a public sector bank or a private sector bank authorised to conduct Government business (ICICI Bank, Axis Bank Ltd or HDFC Bank Ltd) for a sum equal to 3% of the Contract value (~~not applicable for contract value less than Rs 1,00,000/-~~) within 30 days of receipt of the confirmed order. Performance Bank Guarantee should be valid up to 60 days beyond the date of warranty i.e. 12 months (12+02=14 months). The specimen of PBG is given in Form DPM-15 (available in MoD website and can be provide on request).
2. **Option Clause :** The contract will have an Option Clause, wherein the Buyer can exercise an option to procure an additional 50% of the original contracted quantity in accordance with the same terms & conditions of the present contract. This will be applicable within the currency of contract. The Bidder is to confirm the acceptance of the same for inclusion in the contract. It will be entirely the discretion of the Buyer to exercise this option or not.
3. **Repeat Order Clause :** The contract will have a Repeat Order Clause, wherein the Buyer can order upto 50% quantity of the items under the present contract within six months from the date of supply/successful completion of this contract, the cost, terms & conditions remaining the same. The Bidder is to confirm acceptance of this clause. It will be entirely the discretion of the Buyer to place the Repeat order or not.
4. **Tolerance Clause.** To take care of any change in the requirement during the period starting from issue of RFP till placement of the contract, Buyer reserves the right to 20% plus/minus increase or decrease the quantity of the required goods upto that limit without any change in the terms & conditions and prices quoted by the seller. While awarding the contract, the quantity ordered can be increased or decreased by the Buyer within this tolerance limit.
5. **Payment Terms for (Indigenous Sellers).**
 - (a) It will be mandatory for the Bidders to indicate their bank account numbers and other relevant e-payment details so that payments could be made through ECS/EFT mechanism instead of payment through cheques, wherever feasible. A copy of the mandate form prescribed by the RBI to be submitted by the bidder for receiving payments through ECS is at Form DPM-11 (available on MoD website and can be provided on request). The payment will be made as per the following term on production of the requisite documents.
 - (b) 100% payment of the contract amount will be made on delivery and acceptance of complete items by the user. However, part payment can be allowed for stores/spares actually delivered by the supplier and accepted by the user as per DPM Para 7.8.1 on receiving request/ requisition from the supplier.
 - (c) Part Payment can be done twice only, on receipt of complete quantity of stores of each item against which vendor raised the bill.
6. **Advance Payments.**
 - (a) No advance payment (s) will be made.

7. **Paying Authority. CDA Eastern Command, Patna**

The payment of bill will be made on submission of the following documents by the Seller to the Payment Authority along with the bill:-

- (a) Ink-signed copy of contingent bill/Seller's bill pre receipted in triplicate, duly signed.
- (b) Ink-signed copy of Commercial invoice/Seller's bill duly signed.
- (c) A Copy of the Supply Order with UO No and date of IFA, concurrence, where required under delegation on financial powers.
- (d) CRVs in duplicate.
- (e) Inspection note.
- (f) Claim for Statutory and other levies to be supported with Requisite documents/proof of payment such as Excise duty challan, Customs duty clearance certificate, Octroi receipt, proof of payment for EPF/ESIC contribution with nominal roll of beneficiaries, etc as applicable.
- (g) Exemption certificate for Excise duty/Customs duty, if applicable.
- (h) Bank Guarantee for advance, if any.
- (j) Guarantee/Warranty certificate.
- (k) Performance Bank guarantee/Indemnity bond where applicable.
- (l) DP extension letter indicating whether extension is with or without LD.
- (m) Any other document/certificate that may be provided for in the Supply Order/contract.

(Note- From the above list, the documents that may be required depending upon the peculiarities of the procurement being undertaken, may be included in RFP).

8. **Fall Clause.** The following fall clause will form part of the contract placed on successful Bidder:-

- (a) The price charged for the stores supplied under the contract by the Seller shall in no event exceed the lowest prices at which the Contractor sells the stores or offer to sell stores of identical description to any persons/Organization including the purchaser or any department of the Central government or any Department of the State government or any statutory undertaking of the Central or State government as the case may be during the period or till the performance of all Supply Order placed during the currency of the rate contract is completed.
- (b) If at any time, during the said period the Seller reduces the sale Price, sells or offer to sell such stores to any person/organization including by the buyer or any Deptt, of central Govt. or any Department of the State Government or any Statutory undertaking of the Central or State Government as the case may be at a price lower than the price chargeable under the contract,

he shall forthwith notify such reduction or sale or offer of sale to the Purchase/Contracting Authority and the price payable under the contract for the stores of such reduction of sale or offer of the sale shall stand correspondingly reduced. The above stipulation will, however, not apply to :-

- (i) Exports by the Seller.
- (ii) Sale of goods as original equipment at price lower than the Prices charged for normal replacement.
- (iii) Sale of goods such as drugs which have expiry dates.
- (iv) Sale of goods at lower price on or after the date of completion of sale/placement of the order of goods by the authority concerned under the existing or previous Rate Contracts as also under any previous contracts entered in to with the Central or State Govt. Depts, including their undertakings excluding joint sector companies and/or private parties and bodies.

(c) The Seller shall furnish the following certificate to the Paying Authority along with each bill for payment for supplies made against the Rate Contract- "We certify that there has been no reduction in sale price of the stores of description identical to the stores to the stores supplied to the Government under the contract herein and such stores have not been offered/sold by me/us to any person/organization including the purchaser or any department of Central Government or any Department of a State Government or any Statutory Undertaking of the Central or state Government as the case may be up to the date of bill/the date of completion of supplies against all supply orders placed during the currency of the Rate Contract at price lower than the price charged to the Government under the contract except for quantity of stores/categories under sub-clauses (i) (ii) (iii) and (iv) of sub Para (b) above details which are given below-".

9. **Risk & Expense Clause.**

(a) Should the stores or any instalment thereof not be delivered within the Time or times specified in the contract documents, or if defective delivery is made in respect of the stores or any instalment thereof, the Buyer shall after granting the Seller 45 days to cure the breach, be at liberty, without prejudice to the right to recover liquidated damages as a remedy for breach of contract, to declare the contract as cancelled either wholly or to the extent of such default.

(b) Should the stores or any instalment thereof not perform in accordance with the specifications/parameters provided by the SELLER during the check proof tests to be done in the BUYER's country, the BUYER shall be at liberty, without prejudice to any other remedies for breach of contract, to cancel the contract wholly or to the extent of such default.

(c) In case of a material breach that was not remedied within 45 days, the BUYER shall, having given the right of first refusal to the SELLER be at liberty to purchase, manufacture, or procure from any other source as he thinks fit, other stores of the same or similar description to make good:-

- (i) Such default.
- (ii) In the event of the contract being wholly determined the balance of the stores remaining to be delivered there under.

Any excess of the purchase price, cost of manufacture, or value of any Stores procured from any other supplier as the case may be, over the contract price appropriate to such default or balance shall be recoverable from the SELLER. Such recoveries shall not exceed 100% of the value of the contract”

10. **Force Majeure Clause.**

(a) Neither party shall bear responsibility for the complete or partial non-performance of any of its obligations (except for failure to pay any sum which has become due on account of receipt of goods under the provisions of the present contract). If the non-performance results from such Force Majeure circumstances as Flood, Fire, Earth Quake and other acts of God as well as War, Military operation, blockade, Acts or Actions of State Authorities or any other circumstances beyond the parties control that have arisen after the conclusion of the present contract.

(b) In such circumstances the time stipulated for the performance of an Obligation under the present contract is extended correspondingly for the period of time of action of these circumstances and their consequences.

(c) The party for which it becomes impossible to meet obligations under this Contract due to Force Majeure conditions, is to notify in written form the other party of the beginning and cessation of the above circumstances immediately, but in any case not later than 10 (Ten) days from the moment of their beginning.

(d) Certificate of a Chamber of Commerce (Commerce and Industry) or other competent authority or organization of the respective country shall be a sufficient proof of commencement and cessation of the above circumstances.

(e) If the impossibility of complete or partial performance of an obligation lasts for more than 30 Days, either party hereto reserves the right to terminate the contract totally or partially upon given prior written notice of 15days to the other party of the intention to terminate without any liability other than reimbursement on the terms provided in the agreement for the goods received.

11. **Specification.** The following Specification clause will form part of the contract placed on successful Bidder :-

(a) The Seller guarantees to meet the specifications as per Part-II of RFP and to incorporate the modifications to the existing design configuration to meet the specific requirement of the Buyer Services as per modifications/requirements recommended after the Maintenance Evaluation Trials. All technical literature and drawings shall be amended as the modifications by the Seller before supply to the Buyer. The Seller, in consultation with the Buyer, may carry out technical upgradation/alterations in the design, drawings and specifications due to change in manufacturing procedures, indigenization or obsolescence. This will, however, not in any way, adversely affect the end specifications of the equipment. Changes in technical details, drawing repair and maintenance techniques along with necessary tools as a result of upgradation/alterations will be provided to the Buyer free of cost within **30 days** of affecting such upgradation/alterations. The supplier is responsible for obtaining all is specification or relevant product specification needed to complete the supply order and ensure conformity of product required of prior to supplying the items.

(b) The specification of item should as per OEM specifications. In case of requirement the vendor should be able to produce quality check certificate of the spare from NABL or any other authorise Govt agency.

12. **Earliest Acceptable year of Manufacture.** Supplies should be of latest manufacture not earlier than one year of the date of calling of quotations confirm to the current production standard and should have 100% of the defined life at the time of delivery.

13. **Packing and Marking:** The packing of the equipment will be such that the goods are received in good condition at ESD Kankinara.

14. **Quality :** The quality of the stores delivered according to the present Contract shall correspond to the technical conditions and standards valid for the deliveries of the same stores for in seller's country or specifications enumerated as per RFP and shall also include therein modification to the stores suggested by the buyer. Such modifications will be mutually agreed to. The seller confirms that the stores to be supplied under this contract shall be new. The spares supplied should be genuine and procured for the auth vendors/auth stockist/auth distributor.

15. **Inspection Authority:** The stores shall be inspected at ESD Kankinara by BOO for items pertaining to local purchase/market origin items if rejected will be removed from depot premises at the expense of the seller. The Stores will be provided for inspection within the delivery period.

(a) **Inspection Authority.** CQAE/DGQA/Bd of offrs as directed by Accepting Offr. Any authorised Govt of India inspection agency (Inspection charge will be borne by vendor).

(b) **Facilities required.** To be intimated by the Inspection Officer.

16. **Franking clause:-**

(a) **Franking Clause in the case of Acceptance of Goods.** "The fact that the goods have been inspected after the delivery period and passed by the Inspecting Officer will not have the effect of keeping the contract alive. The goods are being passed without prejudice to the rights of the Buyer under the terms and conditions of the contract".

(b) **Franking Clause in the case of Rejection of Goods.** "The fact that the goods have been inspected after the delivery period and rejected by the Inspecting Officer will not bind the Buyer in any manner. The goods are being rejected without prejudice to the rights of the Buyer under the terms and conditions of the contract".

17. **Claims :** The following clause will form part of the contract placed on successful Bidder :-

(a) The claims may be presented either.

(i) On quantity of the stores, where the quantity does not correspond to the quantity shown in the packing list/insufficiency in packing.

(ii) On quality of the stores where quality does not correspond to the quality mentioned in the contract.

(b) The quantity claim for deficiency of quantity shall be presented within **45 days** of completion of JRI acceptance of goods. The quantity claim shall be submitted to the seller as perform DPM-22 (Available in MoD website and can be given on request).

(c) The quality claims for defects or deficiencies in quality noticed during the JRI shall be presented within **45 days** of completion of JRI acceptance of goods. Quality claims shall be presented for defects or deficiencies in quality noticed during warranty period earliest but not late than **45 days** after expiry of the guarantee period. The quality claims shall be submitted to the seller as perform DPM-23 (Available in MoD website and can be given on request).

(d) The description and quantity for the stores are to be furnished to the seller along with concrete reasons for making the claims. Copies of all the justifying documents shall be enclosed to the presented claim. The Seller will settle the claims within 45 days from the date of the receipt of the claim at the seller's office, subject to acceptance of the claim by the seller. In case no response is received during this period the claim will be deemed to have been accepted.

(e) The seller shall collect the defective or rejected goods from the location nominated by the Buyer and deliver the repaired or replaced goods at the same location under seller's arrangement.

(f) Claims may also be settled by reduction of cost of goods under claim from bonds submitted by the seller or payment of claim amount by seller through demand draft drawn on an Indian Bank, in favour of principal controller/Controller of Defence Accounts concerned.

(g) The quality claims will be raised solely by the Buyer and without any certification/countersignature by the seller's representative stationed in India.

18. **Warranty** The following Warranty will form part of the contract placed on successful Bidder:-

Except as otherwise provided in the invitation to the tender, the contractor/seller hereby declares that the goods, stores, articles sold/supplied to the buyer under his contract shall be of the best quantity and workmanship and new in all respects, and shall be strictly in accordance with the specifications and particulars contained/mentioned in the contract.

The contractor/seller hereby guarantees that the said goods/stores articles would continue to conform to the description and quality and aforesaid for a period of twelve months from the date of delivery of the said goods/stores articles to the buyer. If during the aforesaid period of **12 months** the said goods/stores/articles be discovered not to conform to the description and quality aforesaid or not giving satisfactory performance or have deteriorated and the decision of the buyer in the behalf shall be final and binding on the contractor seller to rectify/replace by acceptable goods/stores/articles or such portion or/portions thereof as is found to be defective by the buyer within a reasonable period not exceeding three months or as may be allowed by the buyer in his description on the application made thereof by the contractor/seller , and in such an event the above mentioned warranty period shall apply to the goods/stores/articles rectified /replaced from the date of rectification/replacement thereof otherwise the contractor/seller shall pay the buyer such compensation as determined by the buyer as may arise by reason of the breach of the warranty herein contained.

PART – V : OTHER DETAILS

1. **Evaluation Criteria** - Only those bids will be evaluated which are found to be fulfilling all the eligibility qualifying requirements of the RFP as per DPM 5.6.1. The broad guidelines for evaluation of Bids will be as given below -.

(a) **OEM/OEM auth vendors/ DGQA approved vendor with capacity verification/Enlisted vendors of ESD Kankinara.**

(b) The lowest bid will be decided upon the lowest price quoted by the particular Bidder as per the price format.L1 will be determined only on the Basic price in each item quoted and not on inclusive of all Taxes. Taxes levied by Central/State/Local Govt such as Excise duty, Vat, Service Tax etc on final product will not be used in evaluation criteria for L1 determination. These above mentioned taxes are to be quoted separately by the vendors.

(c) The bidders are required to spell out the rates of Customs duty, Excise duty, Vat, Service Tax. Etc in unambiguous terms, otherwise their offers will be loaded with the maximum rates of duties and taxes for the purpose of comparison of prices. INSTRUCTIONS TO THE BIDDERS

Instructions for Online Bid Submission Instructions to the bidders to submit the bids online through the **GeM Portal**.

1. Possession of valid Digital Signature Certificate (DSC) and enrolment/registration of the contractors/bidders on the e procurement/e tender portal is a prerequisite for e-tendering.
2. Bidder should do the enrolment in the e-Procurement site using the "Click here to Enrol" option available on the home page. Portal enrolment is generally free of charge. During enrolment/registration, the bidders should provide the correct/true information including valid email_id. All the correspondence shall be made directly with the contractors/bidders through email_id provided.
3. Bidder need to login to the site through their user ID/ password chosen during enrolment/registration.
4. Then the Digital Signature Certificate (Class II or Class III certificates with signing key usage) issued by SIFY/TCS/nCode/eMudra or any certifying Authority recognized by CCA India on e Token/Smart Card, Should be registered.
5. The DSC that is registered only should be used by the bidder and should ensure safety of the same.
6. Bidders logs in to the site through the secured log in by giving the user ID/password chosen during enrolment/registration and then by giving the password of the e token/Smart Card to access DSC.
7. In case of limited tender the regd dealers/the bidders invited to participate in the tender will received a notification through e mail wrt to tender and after log in the bidder selects the tender and moves it to "my tender".
