- 15.7. Wherever applicable, the bidder must submit Security deposit and Contract agreement copy within stipulated time as mentioned in tender documents. The formats of the same are mentioned in the FORMS or in the Last section of the tender document as annexures.
- 15.8. PACKING: All material should come with proper packing with an anti-rust protective layer over it. All parts should have a clear, visible identification mark (IM) of the supplier / manufacturer that has to be given on the material and it has to be encircled. All parts should have material description with part number, mode number & quantity over the packing.
- 15.9. Inspection: Goods supplied will be accepted only after our inspection on arrival at HURL Barauni Store.
- 15.10. INTERCHANGEABILITY CERTIFICATE: All material supplied under this PO have to be interchangeable with the existing component/parts. if it fails to be replaced with a new one/ unable to perform its desired functions. Vendor to replace the spare item with suitable item & all cost involved in this is in vendor scope. An interchangeability certificate has to be accompanied with materials/spares supplied.

15.12. Any delays caused by non-compliance with the above instructions may result in delayed payment, and HURL shall not be responsible for such instances.

Note: HURL's total sales turnover has exceeded Rs. 10 crores during the FY 2023-24. Consequently, we now qualify as a buyer under section 194Q of the Income Tax Act, and it is mandatory for us to deduct tax at a rate of 0.1% on the purchase of any goods with a value exceeding fifty lacs in the financial year or the aggregate of such value. Therefore, we kindly request all our suppliers or contractors to discontinue the collection of tax (TCS) on all sales invoices. HURL will deduct tax at a rate of 0.1% TDS under section 194Q of the Income Tax Act.

16. Deviation: The HURL reserves the right to increase or decrease the quantity to be ordered up to 25 percent of the bid quantity at the time of placement of the contract. The HURL also reserves the right to increase or decrease the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

17. Payment Terms:

The Owner shall pay to the Contractor all the admissible payments for the actual delivered quantity within thirty (30) days after certification of the Engineer-in-Charge on receipt of material at the HURL Barauni site.

18. Detailed Scope of Work:

- 18.1. The Vendor is to submit a Guarantee Certificate against manufacturing defects and bad workmanship, which shall be valid for a period of 12 months from the date of installation or 18 months from the date of supply, whichever is earlier.
- 18.2. Vendor should submit Material Test certificate for chemical composition and physical properties from Govt./NABL approved lab.
- 18.3. The complete assembly should be strictly as per drawing and should be supplied in assembled condition only as a complete set.
- 18.4. Item supplied should be properly packed in order to avoid damage during transit and handling of the material.
- 18.5. Vendor to ensure proper tagging of the item with a clear mention to HURL Material code for proper identification of material at site.
