Specification Sheet

The specification of the required items are listed after the below mentioned Terms and Condition along with quantity and delivery schedule. The document along with proof wherever possible, stating the compliance of the same has to be uploaded:

Part 1: General Terms and Condition

- 1 Supplies are subjected to HAL inspection and acceptance. HAL decision on the same is final.
- 2 **Proprietary Article:** The Items are of Proprietary in nature. Hence only the OEM supplier or the Authorized Distributors are allowed to participate in the tender. Valid "Authorized Distributor" Certificate has to be uploaded along with the quote as proof.
- 3 **Shelf Life:** Items should be new and from latest batch of manufacturing. Minimum 80% Shelf Life should be remaining at the time of receipt of goods at HAL Stores. No two deliveries should have the same batch number. HAL reserves the right to reject such items if this condition is not met.
- 4 **Delivery Schedule:** The delivery dates indicated are tentative dates and any changes in the same will be intimated to you 3 months in advance. For future staggered delivery, the delivery window will get opened 45 days before the stated delivery date. No deliveries before this period will be entertained/accepted without the prior acceptance by HAL.
- 5 **Liquidated Damages:** Late deliveries will attract Liquidated Damages @ 0.5% per week of delay or part thereof subject to a maximum of 10% on delayed supplies. Contractual lead time for application of Liquidated Damages will be as per lead time mentioned in the Purchase Order. Please note that HAL Gate Entry date shall be considered as the date of supply.
- 6 **Packing:** Separate individual proper packing (OEM/Manufacturer packing condition) needs to be done with proper identification and life details mentioned on each pack (Part Number, Batch/Lot Number, Date of Manufacture, Date of Expiry, etc). The contractor will be responsible for the stores being sufficiently and properly packed for Tropical Storage and Transport by Rail/Road/Air so as to ensure their being free from loss or damage on arrival at their destination.

- 7 Rejection Clause: In case of Rejection,
 - a) The supplier has to collect all the rejected goods from HAL premises within 15 days of intimation from HAL. OR
 - Proper arrangements with necessary authorization need to be made by suppliers for return of rejected items from HAL stores.
 - b) In case of rejections and return, the supplier has to bear cost of transportation and taxes/other charges including return of rejected goods and supply of new/replacement goods. If such cost is incurred by HAL, such amount will be recovered from pending bills (including that of any division of HAL) OR

Supplier has to transfer such specified amount as per HAL intimation to HAL designated bank account within specified time limits (if not supplied on FOR HAL basis)

Failing which appropriate action as deemed fit by HAL shall be taken by HAL without further notice.

- 8 **Risk purchase**: The Seller will supply quality items as per approved sample and also the quantity intended by the concerned Division in full as per terms and conditions of respective orders. In case the Seller fails to execute the order in time either in terms of quality or in quantity, HAL reserves the right to procure from elsewhere at the risk and cost of the Seller and any extra expenditure incurred due to this purchase is payable by the Seller.
- 9 As part of ISO45001:2018, HAL insists the Seller to comply with all the applicable Health and safety laws and regulations as per Indian factories act-1948.
- 10 As part of ISO14001:2015, HAL insists the Seller to comply with all the applicable Environmental laws and regulations as a minimum to Pollution control board requirements as applicable. The Seller or third interested party should make efforts to adhere to the Environment, Health and Safety (EHS) requirements as per applicable standards.
- 11 HAL, its Customers and Regulatory Authorities have the right to access Seller's manufacturing facilities or of Seller's subcontractors and verify the process with respect to ordered materials and related record with respect to QMS adopted to contract the manufacturing process.

Part 2 : Tender Specific Terms and Condition

- a) Supply shall be covered with OEM COC, Valid Type Approval and Test Report.
- b)Alternate part no. (if any) should be certified by the vendor for its complete interchangeability with respect to fit, form and function with certificate and shall be enclosed with descriptive Literature by the bidder.
- c)Material Safety Data Sheet (MSDS) is mandatory for this item.
- d)Vendor shall indicate life extension procedure if any along with the test report.
- e)While Quoting Vendor Please indicate the Total Standard Shelf life & Standard pack size against each item, Storage Life, Operational Life, Preservation & De-preservation details.
- f)Required staggered delivery will be intimated later based on the production schedule. however tentative staggered delivery is mentioned in the Item lines. You are required to quote prices for staggered delivery as indicated. g)Item supply should be AS & WHEN required basis.
