ADDITIONAL TERMS AND CONDITIONS (ATC)

- 1. <u>CRAC</u> (Consignee receipt-cum-acceptance certificate). Refer para 12 (i) (Page 26) of General terms and conditions on Gem 3.0 (Version 1.19). The CRAC (Consignee receipt-cum-acceptance certificate) will be generated online only after receipt of goods.
- 2. <u>Franking Clause</u>. The following Franking clause will form part of the contract placed on successful Bidder:-
 - (a) Franking Clause in the case of Acceptance of Goods "The fact that the goods have been inspected after the delivery period and passed by the Inspecting Officer will not have the effect of keeping the contract alive. The goods are being passed without prejudice to the rights of the Buyer under the terms and conditions of the contract".
 - (b) Franking Clause in the case of Rejection of Goods "The fact that the goods have been inspected after delivery period and rejected by the Inspecting Officer will not bind the Buyer in any manner. The goods are being rejected without prejudice to the right of the Buyer under the terms and conditions of the contract."
- 3. <u>Manner of Depositing the bids</u>. The Bids will be submitted through Gem by Due date in the following manner. Details of documents are required online given in succeeding Paras:-
 - (a) Experience Criteria 1 Year in any Govt Agency.
 - (b) <u>Tender Conditions Acceptance Certificate</u>. Copy of tender conditions/ acceptance certificate.

 - (f) MSME.
 - (g) Pan Card.

- 4. <u>Second Cover</u>. Bills of Quantities (BoQ) in excel format as downloaded from the Gem with respect to the subject e-tendering. It will be ensured that no changes whatsoever will be carried in the file name or any other data contained in the BOQ. The rates will be filled only in the marked cells. It will also be ensured that the BOQ is not submitted in manual form. Any violation of the above instructions will make the bid invalid and will be rejected.
- 5. <u>Self-Certification</u>. The self certification as indicated in additional documents to be submitted shall be provided duly signed and stamped along with delivery attached as **Appx 'B'**.

6. **Specification**.

- (a) The supplier conforming to the applicable Defence Specification 2020 (**Specifications No 504**) as applicable from time to time will deliver at consignee Supply Depot as per demand placed by Army Supply Depot Vadodara.
- (b) **Quality**. Quality of the stores delivered according to the present tender shall correspond to the Defence Specification 2020 (**Specification No 504**) as applicable from time to time and will be tendered against self-certification by the seller. Self-certificate will be provided by the seller on each date of supply as per the format enclosed in this ATC. The delivered supplies will be subject to random inspections and approval by the Tender Inviting Authority /OC Army Supply Depot Vadodara/or the OC Food Inspection Unit/or the CO Composite Food Laboratory ASC/ or his authorized representative.
- 7. **Rejection**. The following occasion will lead to rejection as per the discretion of tender inviting authority:-
 - (a) NEITHER any separate notice will be served/communicated to the vendor for deduction of compensation/ penalty NOR will any representation be entertained in this regard by any defaulting firm/ vendor.
 - (b) In case of rejection of stock tendered by the firm, it will lift the stocks within 48 hours including Sundays/ holidays at their own expense else rent as applicable will be levied. Any damage to the stock due to non-lifting by the firm will be borne by the firm.
- 8. Firm/ individual black listed/ debarred by the Competent Authority/Supply Transport Brance will not be allowed to participate in the tender.
- 9. <u>Payment Terms for Indigenous Sellers</u>. It will be mandatory for the Bidders to indicate their bank account numbers and other relevant e-payment details so that payments could be made through ECS/NEFT mechanism instead of payment through cheques, wherever feasible.
- 10. **Experience Certificate**. Bidders must submit certificate in proof of experience of min one yr for sup of the item to any Govt agencies.
- 11. **Payment Modalities**. 100% payment will be made on delivery of stores and acceptance by the buyer.

Inspection.

- 12. The entire consignment should be of only one brand and have residual best before period of **90 days**.
- 13. This inspection includes visual scrutiny, weighment and examination of packing material & marking on bags.
- 14. Each batch will be treated as a separate consignment for the purpose of inspection.

- 15. **Option Clause**. The purchaser reserves the right to increase or decrease the quantity to be ordered upto 50% of bid quantity at the time of placement of the contract. The purchaser also reserves the right to increase the ordered quantity by 50% of the contracted quantity during the currency of the contract at the contracted rates. Bidders bound to accept the orders accordingly.
- 16. **Repeat Order Clause**. The contract will have a repeat order clause, wherein the buyer can order up to 50% quantity of the items under the present contract within six months from supply/successful completion of this contract, the cost terms and conditions remaining the same. The bidder is to confirm acceptance of this clause. It will be entirely the discretion of the buyer to place the repeat order or not.
